### EDUCATION:

This three-year program consists of 3,045 hours of education including 1,000 hours of clinical practice. Jennifer's training includes adjunctive therapies such as cupping, moxibustion, tui na massage, acupressure, auricular therapy, and dietary and lifestyle recommendations. Jennifer is certified as a Diplomat in Acupuncture by the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) in January, 2015. This includes certification in Clean Needle Technique. Jennifer is a member of the Acupuncture Association of Colorado. She is a licensed acupuncturist in Colorado. None of these licenses, certificates, or registrations has ever been suspended or revoked. Jennifer is a Nationally Certified Massage Therapist registered with the NCBTMB, as well as a member of the AMTA.
